HISTORY

Since 1947, St. Coletta and Cardinal Cushing Schools of Massachusetts has provided supports, services, and options in a caring and compassionate manner to individuals with disabilities. By emphasizing individual strengths, community involvement, and a holistic approach, St. Coletta's assists individuals in attaining their highest level of independence and personal success.

At the request of the late Richard Cardinal Cushing, the Sisters of St. Francis of Assisi of Milwaukee, Wisconsin, opened the Cardinal Cushing School and Training Center. In 1957, the Sisters established Braintree St. Coletta Day School which serves seventy-five individuals with disabilities between three and twenty-two years of age. Today, St. Coletta and Cardinal Cushing Schools of Massachusetts encompasses the Cardinal Cushing Centers – Braintree, Hanover, Adult Services and Cushing Residence.

St. Coletta and Cardinal Cushing Schools of Massachusetts is a coeducational, not-for-profit, human service organization serving children and adults regardless of race, national origin, or religious belief. The staff of St. Coletta and Cardinal Cushing Schools of Massachusetts is comprised of individuals who continue the mission of helping people with developmental disabilities reach their maximum productivity and integration into society through the promotion of the following values: The creation of a caring community; sharing compassion for others; reverence for creation; stewardship; and peacemaking.
